GENERAL INFORMATION

Border 2.0 is a concentrated, liquid adjuvant premix of retention aids and drift reduction polymers. **Border 2.0**'s aqueous suspension formulation is designed to maintain the performance potential of plant protectants by improving spray droplet adhesion to the leaf surface, while providing excellent drift reduction.

DIRECTIONS FOR USE

The addition of adjuvants to some herbicides, insecticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and plant tissue. Before using **Border 2.0**, the applicator must have experience with the herbicide/insecticide combination, including **Border 2.0**, or must have conducted a phytotoxicity test.

USE RATES

0.25% - 0.50% v/v (2–4 pints) of $\boldsymbol{Border~2.0}$ per 100 gallons of spray solution.

MIXING

Fill the spray tank with at least 50% of the desired finished carrier volume. **Do not** pre-mix Border 2.0 in a mixing vessel or inductor. While the carrier is agitating, add tank mix ingredients in the following order:

- 1. Compatibility agent and/or antifoam, if needed
- 2. AMS, dry formulations (WP, DF, WDG, SP)
- 3. Dry soluble and suspension fertilizers / micronutrients
- 4. Flowable formulations (F & FL)
- Liquid concentrates, suspensión concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
- 6. Emulsifiable concentrates (E, EL or EC)
- 7. Solutions and soluble liquids (S or SL)
- 8. Liquid micronutrients and fertilizers
- 9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- 10. Border 2.0
- 11. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading.
