5. FIREFIGHTING MEASURES

Suitable Extinguishing media: Water spray, foam, CO2, or dry chemicals may be used in areas where this product is stored. Specific Hazards: In a fire or if heated, a pressure increase will occur and the container may burst. Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training.
